Spring is here and summer is fast approaching. This is a reminder to all shareholders who would like to use the pool facilities to obtain their passes. These passes will enable **resident shareholders** to use the pool facility at a discounted rate. For a 2 hour stay, the rate will be \$6.00 and for a 4 hour stay, the rate will be \$8.00. This rate is good Monday thru Friday <u>only</u> and entry will be allowed on first come first serve basis. Also, there will be free swimming for all shareholders on all Mondays (except legal holidays) from 4.30PM to 6.30PM. Rain date will be on Wednesdays. Please come to the management office with your passport size photograph to obtain your shareholder pool pass.

TEMPORARY FUEL SURCHARGE:

The Board of Directors has voted to discontinue the fuel surcharge effective March 31, 2006.

The real estate abatements, STAR credits, veterans and senior exemptions will be credited to your account as of April 01, 2006. As in the past there will be an assessment of \$1.16 per share on your April maintenance bill. As informed to you earlier this assessment was necessary due to increased costs.
