#### **\$400.00 \*STAR\* Rebate in 2007**

In January, 2007 Mayor Bloomberg proposed to send homeowners another \$400 property tax rebate in 2007. Filling out a STAR property tax exemption application will be required in order for owners to receive the rebate in future years. All other eligibility rules and procedures will remain the same. If you have the STAR exemption or have already applied you do not need to fill out a STAR application again in order to receive the 2007 rebate.
