The repaving of the driveway in garage B and the driveway in garage A by 97-10 62nd Drive will start in late spring.

The bids for the roof replacement have been finalized, the work to replace the roofs will commence in the late spring. The first roof to be replaced will be 97-37 63rd Road followed by 97-10 62nd Drive.

LOCAL LAW 87:

The Local law 87 energy audit work has started in the month of March, 2015. This is a new law to determine if the building is being operated efficiently and the consumption of oil, gas, electricity and water will be calculated for Park City 3 and 4 and compared against the standard benchmark. The audit consultant will recommend ways to improve our efficiency and reduce costs.

The audit of the boiler rooms and a large number of apartments has been completed. We will need access to a few more apartments to complete the audit.

We would like to thank all the shareholders who gave access to complete the audit work.

MONTHLY MAINTENANCE PAYMENTS:

ELECTRONICS RECYCLE:

Effective January 01, 2015, The City of New York is implementing new rules regarding disposal of electronic items and Compact fluorescent bulbs. We will be posting all the buildings with instructions for the disposal of such items.

Please note that new blue recycle bins have been placed in all the laundry rooms and we urge all residents who are in the laundry rooms to deposit the items to be recycled in the correct bin.

Also, in all basements we have placed new yellow and red bins to use for recycling electronic and compact fluorescent bulbs. Please locate these bins and recycle all your electronic items. If you are unable to locate the bins, please ask one of the maintenance staff to help you locate the bins. The blue bin is for batteries near the other two bins.

We have also labeled the recycle bins in the incinerator/compactor rooms. One bin is for paper and cardboard and the second bin is for metal and plastic. Please separate your recycle items accordingly and deposit them in the correct bin.

The regular garbage should not be placed in the recycle bins. The regular garbage should be placed in a plastic bag and disposed down the garbage chute. Please do not dump loose garbage in the chute
