If you are over 64 years old or served in the U.S. military, please contact the Management Office at 718-897-2000, you may be eligible for Veteran and senior tax credits.

Please note that the STAR forms must be received before March 31<sup>st</sup>, 2016 by the Department of Finance.

### **TAX DEDUCTION LETTER:**

### **HOMEOWNERS/RENTERS INSURANCE:**

As stated in the House Rules each shareholder is required to purchase Home Owner's insurance which must be kept in effect for the entire time you own your apartment. This also applies to your sub- tenant, should you decide to lease your apartment for the period allowed by the coop (3 years)

Please make sure that either you or your sub-tenant has an insurance policy which covers both liability and property damage. It is in your best interest to do so. It will also help in keeping the co-op's insurance cost down.

### **POST DATED CHECKS:**

Please note that effective March 01, 2016 no post dated checks will be accepted. If you mail post dated checks, they will be deposited when they are received. Park City 3 and 4 Apartments, Inc will not be responsible for any fees charged if any items are returned unpaid.

### **CATWALK DOORS:**

Please keep the catwalk doors closed at all times. This is required by the Fire Code of New York City. Also, open catwalk doors lead to elevators swing doors not closing properly and the elevators are stuck on the floor where the door is left open.

### **GARAGE:**

Please note that the speed limit inside the garage is 5 MPH, anyone exceeding that speed is in violation of their Parking Space License. <u>Please keep your headlights on going into and coming out of the garage</u>. Smoking is not permitted in the garage.
