## **TAX CREDITS AND ASSESSMENTS:**

As in the past, in order to pay for Capital Improvements, Repair, Maintenance and Upgrades mandated by the City and State of New York, the Board of Directors has assessed the shareholders a portion of their individual tax abatement credit. This year again there will be an assessment charge to pay for FISP (Local law 11) 9<sup>th</sup> cycle, Local Law 152 (paint and test all gas lines) and Local Law 97(reduction of emissions).

All the tax abatement credits have been given in the month of June, 2021. A onetime assessment of \$3.85 per share will be charged to your account in the month of June, 2021.

# XRF TESTING FOR LEAD BASED PAINT:

All shareholders were sent information on Local Law 31 of 2020 which amends Local Law 1 of 2004. The law requires all apartments to be tested by a XRF machine used by a EPA licensed contractor. The city is issuing violations and charging substantial penalties for non-compliance. The testing will be in the following order:

- 1. All apartments with children under 6 years of age have to be completed immediately and all documentation available for the HPD on or before August 2021.
- 2. All apartments currently occupied with a sub-tenant have to be tested immediately and all apartments where a new sub-tenant is moving in have to be done before the sub-tenant moves in.
- 3. All apartments which are sold will be tested before the transfer is completed to the new owner.

Due to the change in the law previous leads tests are no longer accepted by the city. All contractors have to produce a certificate that they are approved by EPA to conduct lead based paint activities pursuant to Title 40 CFR part 745.226 and part 745.227.

4. All 1100 apartments have to tested on or before August 2025. There are no exceptions. Please visit the following link for further information:
